I farm 4,500 stock units on 1,100 hectares at Roxburgh with my wife and our two teenage kids. I believe in people growing their wealth from farming their land. When farmers are financially strong, they have true choices — whether that's building a legacy, pursuing growth, environmental improvements, or simply farming the way they're passionate about. I love sheep and sheep farming and believe in the future of our industry.



I bring over 10 years of governance experience in my community, including service as a BLNZ Associate Director and extensive governance training. As a former accountant, who went on to purchase and run a farm, I pair practical on-farm knowledge with strong financial literacy and business discipline.

Down here in the south, we deal with a unique climate and set of challenges. We need someone at the BLNZ Board table who understands this region. There's been a real lack of awareness about the role winter cropping plays in our systems. I'm not afraid to speak up and push back against policies that don't reflect the reality of southern farming.

Looking ahead, forecasts say \$150 billion worth of farms will change hands over the next decade. I'm passionate about attracting young talent to the industry. BLNZ's Future Farmers programme is a great step in helping young people understand the real opportunities — financial and lifestyle — that farming offers.

Around 60% of our beef exports come from dairy herds, and dairy farmers pay a big part of the levy. That contribution needs to be recognised. I'm supportive of the Beef Progeny Programme and want to see the value chain better aligned so all farmers can get real returns off beef genetics.
